[REDACTED] WENT TO THE STAFF MEMBERS AT THE [REDACTED] AND TOLD THEM OF A STAFF MEMBER, BY THE NAME OF
KEN BECK, HAD FELT OF THEIR PRIVATE PARTS. WITHIN THE NEXT FEW DAYS THE [REDACTED] SPOKE TO AL WEIRMAN, THE DIRECTOR
OF [REDACTED] AL WEIRMAN INTERVIEWED THESE CHILDREN SEPARATELY IN HIS OFFICE AND A AUDIO TAPE RECORDING
WAS UTILIZED. ALL [REDACTED] GAVE ME INTERVIEWS THAT THEY TOLD AL WEIRMAN THAT KEN BECK HAD FELT OF THEIR PRIVATE
PARTS ON SEPARATE OCCASIONS AND POINTED TO THE PRIVATE PARTS THEY WERE SPEAKING OF. AL WEIRMAN TOLD THEM HE WOULD TAKE
CARE OF THE PROBLEM AND THAT KEN BECK WOULD NO LONGER WORK THERE. HOWEVER AL WEIRMAN FAILED TO REPORT THESE ACTS TO

AL WEIRMAN KNOWINGLY WITHHELD THE FACTS THAT THE CHILDREN HAD REPORTED ACTS OF SEXUAL ABUSE COMMITTED UPON THEM BY THE
STAFF MEMBER, KEN BECK AT THE [REDACTED] AND DID NOT REPORT SUCH KNOWLEDGE AS REQUIRED BY F.S. 415.504
ALSO AL WEIRMAN COERCED [REDACTED] INTO NOT TELLING HER MOTHER, BY TELLING HER IF SHE DID THEY WOULD ALL GO TO
FOSTER HOMES, COMMITTING A FELONY OF THE THIRD DEGREE BY TAMPERING WITH A WITNESS, F.S. 914.22

1) Your affiant is currently employed as a Detective with the St. Lucie County Sheriff's Department, St. Lucie County, Florida and that your affiant has so been employed as a full-time officer for approximately five (5) years. That affiant is a citizen and resident of the State of Florida, and that he has good reason to believe and does believe that those certain premises located in St. Lucie County, Florida, described as follow, to-wit:

Begin at the intersection of Midway Road and [REDACTED] and proceed north on [REDACTED] approximately .7 tenths of a mile to [REDACTED]. The building to be searched is located on the east side of the roadway and is a one story CBS white building with blue trim. A sign in front of building states [REDACTED]

There is now being kept in said premises certain evidence to-wit: Audio tapes, written records, individual children files, personnel files, and other evidence relevant to proving that a felony has been committed in violation of Florida State Statute 800.04 pertaining to lewd & lascivious or indecent assault or act upon or in the presence of a child, and Florida State Statute 794.011, pertaining to sexual battery.

That the facts tending to establish the grounds for this application and probable cause of affiant believing that such facts exist are as follows:

On September 24, 1989, your affiant was informed by Mark Creel of H.R.S. of a possible sexual molestation on several children at [REDACTED] by the former director and staff member Ken Beck who is now no longer employed at [REDACTED]

During interviews with [REDACTED] and [REDACTED] it was learned that the Director Allen Weirman several weeks ago had been notified about these alleged incidents and in his investigation, he had made audio and written recordings of the childrens statements. Mark Creel informed me that he asked Allen Weirman for the taped statements and Mr. Weirman informed him they had been destroyed. Two of the children, [REDACTED] and [REDACTED] were told by Allen Weirman and another staff member, not to tell their parents. This was substantiated by Donna Bucci, a staff member at [REDACTED]. During the interview with Donna Bucci, she advised she believed there were written incident reports by Allen Weirman on what the children said. She also informed this affiant that when she was employed by [REDACTED] on February 14, 1989, she heard conversations by other staff members that Ken Beck, then director, had been accused of sexually molesting several children by the names of [REDACTED] and [REDACTED] and [REDACTED]. [REDACTED] advised that the staff workers maintain a written daily log and there are incident reports maintained about investigations by the director and staff workers which are kept in several locations within [REDACTED]. Donna Bucci informed this affiant that the staff members were told not to discuss the incidents with anyone unless Allen Weirman was present.

During this affiant's conversation with Allen Weirman by telephone, he informed me that he would not allow this affiant to interview the children unless he or his attorney was present in the room. Due to the fact that Allen Weirman has been uncooperative and that he did not report these latest incidents to law enforcement or to H.R.S. which is in violation of Florida State Statute 415.504, it is doubtfull he will cooperate in the future. There is a possibility of prior sexual molestation which was not reported. Due to Allen Weirman's statement to Mark Creel that the tapes were destroyed, your affiant feels that if we do not retrieve these records immediately, they will be destroyed.

Based on the above information, this affiant has probable cause to believe and does believe that located on the

premises is evidence to-wit: Audio tapes, written records, and other evidence relevant to proving that a felony has been committed in violation of Florida State Statute 794.011 pertaining to sexual battery, and Florida State Statute 800.04 pertaining to lewd & lascivious or indecent assault or act upon or in the presence of a child.

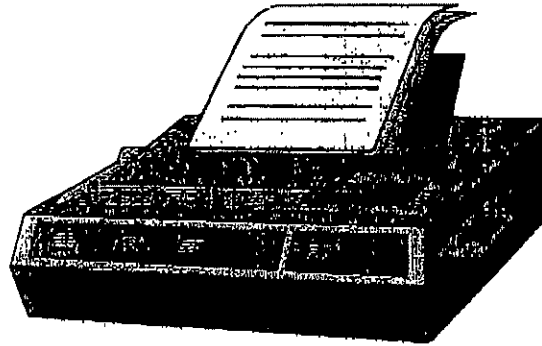
