Summary of Offenses and Probable Cause Affidavit

ON 1/28/2011 I RESPONDED TO 114 NE ESTIA LN PORT ST LUCIE. UPON ARRIVAL I MADE CONTACT WITH CANDACE WEIERMAN. CANDACE WAS CRYING AND BLEEDING FROM HER FEET AND HANDS. CANDACE SAID SHE WAS DRAGGED FROM HER VEHICLE AND THROWN ONTO HER HOME BY HER HUSBAND JONATHAN WEIERMAN. SHE SAID THEY HAD BEEN ARGUING ABOUT MONEY ALL DAY.

CANDACE STATED TO GET AWAY FROM HIM SHE KICKED OUT THE LIVINGROOM WINDOW AND RAN DOWN THE STREET. SHE SAID SHE USED A BYSTANDERS PHONE TO CALL 911. CANDACE'S INJURIES WERE CONSISTANT WITH KICKING OUT A GLASS WINDOW. SHE REFUSED RESCUE.

CANDACE FILLED OUT A SWORN STATEMENT.

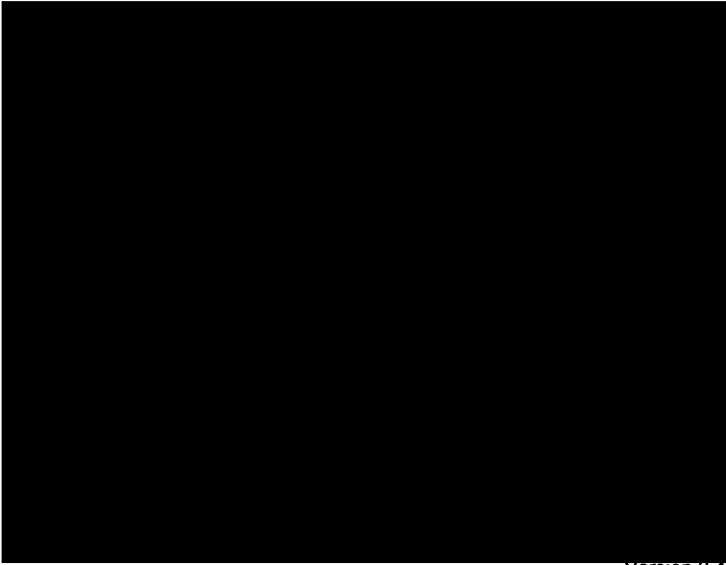
I SPOKE WITH JONATHAN AND HE ADMITTED TO ARGUING BUT DENIED TOUCHING CANDACE.

THE DIRT WAS DISTURBED NEAR CANDACE'S DRIVERS DOOR ALONG WITH A LAWN ORNAMENT THAT WAS BROKEN. THIS IS CONSISTANT WITH SOME SORT OF STRUGGLE. ALSO THE LIVING ROOM WINDOW WAS BROKEN OUT.

BASED ON THE CANDACES SWORN STATEMENT AND THE PHYSICAL EVIDENCE JONATHAN WAS ARRESTED AND TRANSPORTED TO THE COUNTY JAIL FOR PROCESSING.
