

RECEIVED THE MESSAGE TO CALL SHELIA. RONALD CARTER ALSO INFORMED ME THAT MICHAEL WARREN HAD STOLE A CHRYSLER LEBARON FROM PAYLESS RENT A CAR. ACCORDING TO RONALD CARTER, HE BELIEVED THIS OCCURRED BECAUSE DONALD CARTER HAD TAKEN THE TELEPHONE CALL, AND THAT PAYLESS WAS SUING BARGAIN MOTORS OVER A YELLOW PAGE AD. ACCORDING TO RONALD CARTER, DONALD CARTER HAD ANSWERED THE TELEPHONE WHEN THE WOMAN MRS. RESTIVO CONTACTED BARGAIN MOTORS. RONALD CARTER STATED THAT HIS BROTHER DON CARTER TOLD THE WOMAN TO LEAVE THE KEYS ON THE WINDSHIELD WIPERS, AND THAT SOMEONE WOULD BE COMING TO PICK UP THE VEHICLE. RONALD CARTER STATED DON CARTER SUBSEQUENTLY CONTACTED MICHAEL WARREN, WHO WAS OUT REPOSSESSING VEHICLES WITH SHELIA KEEN THAT EVENING. RONALD CARTER BELIEVES THAT MICHAEL WARREN THEN WENT TO PAY LESS AND STOLE THE CHRYSLER LEBARON. FOR FURTHER INFORMATION, REFER TO THE TAPED STATEMENT FROM RONALD CARTER.

ON 11-1-90 AT APPROXIMATELY 2130 HOURS, I WAS CONTACTED BY DET. SGT. SESSA WHO HAD INFORMED ME THAT A PERSON KNOWN AS JOHN DOUGLAS MORAN, JR., WANTED TO TALK TO THE POLICE CONCERNING THE HOMICIDE OF MARLENE WARREN AND OTHER CHARGES AGAINST MICHAEL WARREN. JOHN MORAN, JR., WANTED TO BE PICKED UP AT HIS RESIDENCE AT APPROXIMATELY 0715 HOURS ON 11-2-90, SO THAT HE COULD BE INTERVIEWED.

ON 11-2-90 AT APPROXIMATELY 0715 HOURS, I DID ARRIVE AT JOHN MORAN JR.'S., RESIDENCE LOCATED AT 3063 FLOWEVA STREET, APARTMENT C, WEST PALM BEACH, FLORIDA. THERE I MET WITH JOHN MORAN, JR., WHO VOLUNTARILY ACCOMPANIED ME TO THE PALM BEACH COUNTY SHERIFF'S OFFICE. AT APPROXIMATELY 0740 HOURS ON 11-2-90, DET. VAGA AND MYSELF THEN INTERVIEWED JOHN DOUGLAS MORAN, JR., W/M, DOB 11-23-70. DURING MORAN'S TAPED STATEMENT, HE INFORMED ME THAT HE USED TO BE A PART-TIME EMPLOYEE OF BARGAIN MOTORS, AND HE HAD RUN A DETAILING SHOP AT THE FARMER'S MARKET FOR MICHAEL WARREN. MORAN STATED THAT HE DID MEET THE VICTIM MARLENE WARREN ON SEVERAL OCCASIONS, HOWEVER, HE WAS NOT A CLOSE PERSONAL FRIEND OF HERS. MORAN JR. STATED THAT MICHAEL WARREN WAS NOT HAVING A GOOD RELATIONSHIP WITH HIS WIFE MARLENE WARREN. MORAN STATED THAT HE HAD BEEN AT BARGAIN MOTORS SEVERAL TIMES SINCE JULY, 1989, AND OVERHEARD MICHAEL WARREN ARGUING WITH HIS WIFE MARLENE WARREN ON THE TELEPHONE. DURING THESE CONVERSATIONS, MORAN JR. STATED THAT HE KNEW MICHAEL WAS TALKING TO HIS WIFE, BECAUSE THE PHONE CALL HAD BEEN ANSWERED BY EITHER DELLA RAYONE OR LINDA DAVIS, WHO INFORMED MICHAEL WARREN BY YELLING YOUR WIFE IS ON THE PHONE. MORAN STATED THAT HE THEN OBSERVED MICHAEL PICK UP THE PHONE, AND TALK TO HIS WIFE. ON SEVERAL OCCASIONS SINCE JULY, 1989, THROUGH DECEMBER, 1989, MICHAEL WARREN HAD HUNG UP THE PHONE AFTER ARGUING WITH HIS WIFE, AND MADE A COMMENT, "I'M GONNA KILL THE BITCH". MORAN STATED THAT HE DID HEAR THIS SEVERAL TIMES FROM MICHAEL WARREN OVER THE PERIOD OF MONTHS FROM JULY TO DECEMBER OF 1989. MORAN ALSO STATED HE HEARD DONALD CARTER STATE AT THAT TIME, THAT "I WISH MIKE WOULD KILL THE BITCH AND GET IT OVER WITH". MORAN BELIEVES THAT MICHAEL WARREN DID HAVE HIS WIFE MURDERED, BUT HAS NO OTHER
